Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To give more people the freedom of Civil Rights without obstruction or interference of the government.

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SECTION 1. SHORT TITLE**

This act may be cited as the "Civil Rights Act"

### SEC 2. DISALLOWING DICTATORSHIP IN PRIVATE SECTOR

- a) It shall be unlawful for any dictatorship occurring within the private sector that serves the free public.
- b) Anyone Caught doing so is subject to Federal Dungeon time or a fine up to two hundred dollars.

### SEC 3. DISALLOWING PROVINCES TO MAKE DICTATORIAL LAWS

- a) It shall be unlawful for any province to make any law that obstructs or contradicts this act thereto
- b) Should a province make a law, the federal courts established by the New Bacon Constitution shall act upon the situation quickly and professionally.

### **SECTION 4. PEOPLE'S RIGHTS**

All citizens of New Bacon shall exercise his or her rights as a citizen not denied or abridged by the New Bacon Government or the New Bacon Provinces; all rights are hereby reserved in the New Bacon constitution, which is the supreme law of the land.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To establish territorial home rule to all the New Bacon territories

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SECTION 1. SHORT TITLE**

This act may be cited as the "Territorial Home Rule Act of 2014"

### SEC 2. TERRITORIAL LEGISLATURES

- a) All territories are hereby granted a legislature that can do the following:
  - Make decisions for the territory that comply with the New Bacon Constitution
  - 2) Elect their chosen leaders for each house
  - 3) Impose taxes as necessary in compliance with the New Bacon Constitution
  - 4) Impeach any elected official or Judge holding an office
- b) The legislature shall make laws regulating anything thereof in compliance with the New Bacon Constitution

### **SEC 3. TERRITORIAL EXECUTIVE**

- a) Each territory shall have an elected Governor holding office with the following:
  - 1) Regulation of Terms by the Legislature
  - 2) A bureaucracy along with the territorial executive department
  - 3) The governor is the head of the Bureaucracy

### **SEC 4. THE JUDICIARY**

- a) Each territory shall have a judiciary that can balance out the Power of the Government of the Territory.
- b) All judges shall have the power of judicial review from the Government of the territory.

#### SEC 5. COVERAGE

Anything that is not covered in this act shall solely be covered by the territories.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To create a National Banking System for New Bacon

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SECTION 1. TITLE**

This act shall be cited as "The New Bacon National Banking and Reserve Act of 2014"

### **SEC 2. THE NATIONAL BANK**

- a) This act shall create a National Banking system of the United Provinces of New Bacon without the interference of the Regional Congress and the Executive Branches of the New Bacon Government.
- b) The National Bank shall have the power to do the following without the necessity of the Regional Congress and New Bacon Executive Branches:
  - 1) Establish monetary policy
  - 2) Establish interest rates
  - 3) Set Reserve Requirements

### SEC 3. THE BOARDS

The New Bacon Reserve shall have a board [only the board president appointed by the New Bacon executive]

### **SEC 4. FUNDING**

The New Bacon Government shall not appropriate funding for the New Bacon Reserve; funding shall strictly be private or independently be self-funded.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

## An Act

To set the minimum wage

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SEC 1. MINUMUM WAGE LIMIT**

The minimum wage shall be eleven dollars and sixteen cents an hour for all of New Bacon.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To establish a national park system

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SECTION 1. TITLE**

This act may be cited as "The National Park Act"

### **SEC 2. PRESIDENTIAL AUTHORITY**

The President shall have the authority to preserve and protect all nationally owned lands across the country and shall make a) an executive order that establishes the park name b) maintenance work that is in compliance with appropriations.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

## An Act

To merge Varangian Guard and Star Wars Battlefront raiding and defending installations

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SEC 1. REFERENDUM**

- a) There shall be a referendum that will establish a poll required for this law to pass.
- b) The regions of Varangian Guard and Star Wars Battlefront shall merge and become The Battle Guard which will be the official military of the Government New Bacon

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To establish communicational authority to track citizens determined to be a danger

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### SEC 1. COMMUNICATION WATCHES

This act shall make national law enforcement track any threats on social media that can be a harm to someone or property.

### SEC 2. REQUIREMENTS OF TRACKING

- a) It shall be unlawful for any law enforcement agency within the New Bacon Government to track on social media or any other communications without a warrant issued
- b) Violation is considered a crime and can result in fines or dungeon time

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To give appearance authority to the Country of New Bacon to exercise maintenance of the map.

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### SEC 1. TITLE

This act may be cited as "The New Bacon Appearance Act of 2015"

### SEC 2. GOVERNMENT POWER TO REPEAL LAW

- a) The Mystical Council Legislature Shall have the power to revoke this law at any given time; the founder [oakplumington] shall disband the position in emergency situations.
- b) The Government of New Bacon, its legislature, and its judiciary shall declare the law null and void at the request of a regional member
- c) IN GENERAL- New Bacon shall have the said powers
  - 1) The said country shall have authority over appearance

### **SEC 3. AGENCY**

The agency responsible for the map shall be the New Bacon Geological Survey

### SEC 4. REPEAL

Section two of this law is now voided

### SEC 5. AMENDMENT TO SECTION THREE

a) Section Three Currently States, "The agency responsible for the map shall be the New Bacon Geological Survey" This shall be amended to "The Agency responsible for the map Shall be the Bacon-Mystical Council Geological Survey"

### SEC 6. BOARD

The Governing body of the Map agency shall be the Geological Survey Board and shall make the following decisions:

- a) Approve or disapprove claims on the map
- b) Discussion of other map options
- c) Shall be an appointed board by the New Bacon President or World Assembly Delegate of the Mystical council in case of a Vacancy

### An Act

To establish several executive agencies to the executive branch of government

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SEC 1. THE DEPARTMENTS**

- a) The Following tags shall identify law enforcement and security departments; the tags are, [law enforcement], [security enforcement]
- b) The executive branch of the New Bacon Government shall have the agencies listed:
  - 1) The Office of the New Bacon President
  - 2) Department of the Battle Guard: Which shall include the subordinate departments and agencies of, Army, Navy, Marines, New Bacon Coast Guard [dept of homeland security during peacetime], Office of the Minister of Defense [elected regionwide], National Guard Bureau, and Air Force
  - 3) Department of Interior and Insular Affairs: which shall include the subordinate departments and agencies of, Office of the Secretary of Interior, National Park Service, and Insular Management Agency
  - 4) Department of Education: Which shall include the subordinate departments and agencies of, Office of the Secretary of Education, College Affairs, and Test Readiness
  - 5) Department of Justice: Which shall include the subordinate departments and agencies of, Office of the Attorney General, Federal Office of Investigation and Law [law enforcement], National Crime Agency [law enforcement], and New Bacon Marshals [law enforcement]
  - 6) Department of Health: Which shall include the subordinate departments and agencies of, Office of the Secretary of Health
  - 7) Department of Homeland Security: Which shall include the subordinate departments and agencies of, Secretary of Homeland Security, Transportation Security Agency [security enforcement], Homeland Security Investigation [law enforcement], New Bacon Coast Guard [peacetime], New Bacon Secret Service [law enforcement], New Bacon Customs and Border Protection [law enforcement], Federal Protective Services [law enforcement] Bacon Emergency Management Agency
  - 8) Department of Foreign Affairs: Which Shall include the following subordinate departments and agencies of, Office of the Secretary of Foreign Affairs, and New Bacon Ambassadors Unit

- 9) Department of Transportation: Which Shall include the following subordinate departments and agencies of, Office of the Secretary of Transportation, New Bacon Aviation Administration, New Bacon Highway Administration, Nautical Safety Administration, and National Transportation Safety Board
- 10) Department of Treasury: Which shall include the following subordinate departments and agencies of, Office of the Secretary of Treasury, Internal Revenue Agency, Tariff Agency, National Sales Tax Agency, Corporate Revenue Agency

### SEC 2. NEW BACON COAST GUARD POWERS

The New Bacon Coast Guard Shall be established under the Department of Homeland Security during peacetime and shall be in the Department of Defense, under the Department of the Navy during the time of War.

### SEC 3. FEDERAL PROTECTIVE SERVICE DUTIES

a) The Federal Protective Service shall protect all the federally owned buildings in the executive and judicial branches of governments.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

To establish legislative agencies to the congress

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### SEC 1. TITLE

This act can be called the "Legislative Agencies Act"

### **SEC 2. STRUCTURE**

- a) The tags [law enforcement] and [security enforcement] shall be used to identify security
- b) This act shall hereby certify the following legislative agencies within the legislative branch of the New Bacon Government:
  - 1) New Bacon Capitol Visitors Center
  - 2) New Bacon Capitol Police [law enforcement]; this agency shall patrol the New Bacon Capitol, all legislative buildings and annexes throughout Washington DC
  - 3) Congressional Ethics Office

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the ninth day of June Two Thousand and Seventeen

### An Act

That creates a space agency

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SEC 1. OVERVIEW**

The Agency in charge of all space explorations and missions shall be the New Bacon Space Agency.

### SEC 2. THE BRANCH OF GOVERNMENT

This agency shall be in the executive branch of the New Bacon government; this should include the appropriations funding for the agency that is independent from any department.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the eleventh day of June Two Thousand and Seventeen

### An Act

To establish the Judicial Courts of the United Provinces of New Bacon

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SEC 1. SHORT TITLE**

This act may be cited as the "Judiciary Act (Revised)"

### SEC 2. THE SUPREME COURT JUSTICE REGULATION

The Supreme Court shall have no more than nine justices on the court with one chief justice and the others associate justices

### **SEC 3. THE APPELATE COURTS**

- a) There shall be fifteen federal circuits of the Appellate Courts which will appeal to the inferior courts
- b) Circuit boundaries shall be established by congress but not written as law as changes can be made to the said geographic boundaries; a stamp must be on all maps approved by congress.
- c) Circuit fifteen shall be the federal circuit and is the only unique circuit that appeals to the New Bacon government; this court shall also review and interpret not only New Bacon law but also regional law to determine the chances of a Succeeding Trial when the Chief justice is elected to the judiciary of the Regional Government.
- d) There shall be one appellate court per circuit
- e) The appellate courts shall have jurisdiction nationwide

### SEC 4. THE DISTRICT COURTS

- a) The District Courts shall be established trial courts in the following broken up districts:
  - 1) Labrador: District of Labrador
  - 2) Yukona: District of Yukona
  - 3) Hawaii: District of Hawaii
  - 4) Washington: Eastern District; Western District
  - 5) Oregon: Northern District; Southern District
  - 6) California; Eastern District; Western District; Central District; Southern District
  - 7) Nevada: District of Nevada
  - 8) Idaho: Northern and Southern Districts
  - 9) Utah: Western and Eastern Districts
  - 10) Arizona: District of Arizona
  - 11) Montana: Western and Eastern Districts
  - 12) Wyoming: District of Wyoming

- 13) Colorado: District of Colorado
- 14) New Mexico: Northern, Western, Eastern Districts
- 15) Texas: Northern, Central, Western, Eastern, Southeastern Districts
- 16) Oklahoma: Western, Eastern Districts
- 17) Kansas: Western, Eastern Districts

- 19) South Dakota: District of South Dakota

### SEC 5. TERRITORIAL COURTS

- a) The territories of New Bacon shall have the following federal court districts:
  - 1) (Goldfair) Puerto Rico: District of Goldfair
  - 2) St. Pierre and Miquelon: Joint with District of Labrador
  - 3) Bahamas: District of the Bahamas

### SEC 6. ENFORCEMENT ARMS OF THE COURTS

a) The Enforcement arm of all courts shall be the New Bacon Marshals established under the act "To establish several executive agencies to the executive branch of government" Reference [Sec 1. B. 5.]; the New Bacon marshals shall conduct warrants, issue court subpoenas and other various operations within the court system

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the eleventh day of June Two Thousand and Seventeen

## An Act

To establish federal tax revenue for the Government of New Bacon

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### SEC 1. CORPORATE INCOME TAX

The Corporate Income Tax for New Bacon Shall be 1.69% valid only in the Provinces and not the territories.

### **SEC 2. SALES TAX**

The Sales Tax shall be 3.21%, valid only in the New Bacon Provinces and not the territories.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the tenth day of October Two Thousand and Seventeen

## An Act

To establish a Mandatory Curfew in Federal Emergency Situations

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

### **SECTION 1. SHORT TITLE**

This act shall be called the "Curfew Act"

### **SECTION 2. POWERS OF THE EXECUTIVE**

During times of a Federal Emergency in New Bacon the New Bacon President shall have the power to establish curfew times no greater than twelve hours a day.

### **SECTION 3. CURFEW AND ENFORCEMENT**

- **a)** If there shall be a curfew in New Bacon, it must be only mandatory when the President declares a State of Emergency for the country. Other instances may include a federal curfew for individual states in case of emergencies.
- **b)** The New Bacon Marshals shall be the main enforcer of the curfew, with the help of Provincial and Local Law enforcement Agencies in New Bacon
- c) Anyone caught breaking this curfew can expect fines or dungeon time

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the eleventh day of October Two Thousand and Seventeen

### An Act

To establish the Official Region of New Bacon

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

#### **SEC 1. SHORT TITLE**

This statute shall be called the "Official Region Act"

### SEC 2. The Official Region Residence Nationstates

The official region that New Bacon resides in shall be The Mystical Council.

#### **SEC 3. Residence Rules**

New Bacon shall not move from the region stated unless in the following instances,

- a) The Founder will not cooperate with regional government
- b) Region is inactive
- c) Region is in danger of being taken over due to lessened influence

### SEC 4. Regional Law Reference

a) In accordance to the [Basic Rights of Nations, § 14] This nation has the absolute right to move from the region from the said instances whether it be a congressional vote or the voice of the New Bacon People by referendum.

Begun and held at the City of Washington, District of Columbia, the seat of the Government of New Bacon, on the eleventh day of June Two Thousand and Seventeen

### An Act

To establish a series of laws making such things unlawful

Be it enacted by the New Bacon Regional Congress, the Senate and House of Commons assembled,

#### SEC 1. TITLE

This shall be called "Public Law 16"

### SEC 2. EUTHANASIA: PUBLIC LAW 16-01

- a) It shall be unlawful for anyone to practice euthanasia or to even practice it in the medical field.
- b) Anyone caught can face a fine up to two hundred dollars or up to two months dungeon time

### SEC 3. HUMAN ORGANS: PUBLIC LAW 16-02

- a) It shall be unlawful for anyone to sell human body parts or organs
- b) Anyone Caught can face automatic dungeon time up to 1 month.

### SEC 4. WEAPONS IN GOVERNMENT BUILDINGS: PUBLIC LAW 16-03

- a) It shall be unlawful for any persons to bring weapons in to any of the New Bacon Government Buildings thereto
- b) Anyone Caught will have their weapon privileges suspended for up to one month.

### SEC 5. BRIBERY: PUBLIC LAW 16-04

- a) It shall be unlawful for anyone to bribe in any level of Government within New Bacon.
- b) Be it anyone caught, he or she must pay back the bribery money over a period.

### SEC 6. INFLUENCE AND PASSWORD PROTECTING: PUBLIC LAW 16-05

- a) It shall be unlawful for New Bacon to password-protect the region without due process of the law; the only instances if the region be password protected are the following:
  - 1) If the region is at elevated risk of danger
  - 2) If the founder can't be revived
  - 3) If the region is not recruiting anymore
